NOTE

PAYMENT

You must pay the inspection fee by check or money order payable to the Jackson County ESD No.3 at the time the inspection is performed by Fire Department.

REINSPECTION

One "reinspection," if necessary, will be included in the cost of the original request. If additional inspections become necessary because of non-compliance, each subsequent inspection will require form and the necessary fee.

INSPECTION DATE

Inspections will be performed in a timely manner

OUTSIDE OF DISTRICT BOUNDARIES THAT REQUEST INSPECTION

The Jackson County ESD No. 3 will conduct inspections outside of District boundaries but within Jackson County. These will be done when staffing allows. A fee will be imposed for inspections outside the District's boundaries.
